

**Addendum to Agreement
Relating to the California Consumer Privacy Act
Effective _____, 20__**

COMPLIANCE WITH THE CALIFORNIA CONSUMER PRIVACY ACT (CCPA)

_____ is a Service Provider to CHS as defined in California Consumer Privacy Act of 2018, Cal. Civ. Code §1798.100 *et seq.* (the CCPA). _____ (“Service Provider”) agrees to comply with the CCPA and its regulations, as either may be amended or updated from time to time. Service Provider agrees to comply with the requirements below in relation to any Personal Information processed in connection with Service Provider’s performance under the Agreement between the Service Provider and CHS dated _____, 20__ (“Agreement”).

As used herein, “Personal Information” means information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular individual or household, where that individual is resident of the State of California.

As used herein, “Commercial Purpose” means to advance Service Provider’s commercial or economic interests, such as by inducing another person to buy, rent, lease, join, subscribe to, provide, or exchange products, goods, property, information, or services, or enabling or effecting, directly or indirectly, a commercial transaction.

- a) Limitation on Use of Personal Information. Service Provider shall not sell, retain, use or disclose the Personal Information provided to Service Provider by the CHS for any purpose, including, without limitation, a commercial purpose, other than for the specific purpose of performing the services for the CHS specified within the Agreement.
- b) Certification of Service Provider. By its signature below, Service Provider certifies that Service Provider, including all of its personnel who are providing services and/or receiving Personal Information from the CHS pursuant to the Agreement, understand the limitations and restrictions set forth above and will comply with them.
- c) Assistance with Requests. Service Provider shall promptly take such actions and provide such information as CHS may request to help the CHS fulfill requests of individuals who exercise their rights under the CCPA and its regulations, including, without limitation, requests to access, delete, opt out of the sale of, or receive information about the processing of, Personal Information pertaining to them.
- d) Inconsistent Provisions. To the extent that any provisions of this Addendum are inconsistent with provisions of the Agreement, the provisions of the Addendum shall govern.
